

ENTREPRENEURIAL SUPPORT ACT VISAS (LEY/14 2013)

These comprise of the following categories of residence visas for -

- Highly Qualified Professionals
- Intra-Company Transfer
- Training/Research
- Entrepreneurs
- Family Members
- Internships
- Capital Investment
- Real-Estate Investors
- Investor Corporate Project

DOCUMENTS REQUIRED

- 1. 2 National visa application forms, duly filled out, signed by the person in whose name the will be issued, and 2 recent passport size photographs in colour and with white background attached to the form.
- 2. Power of attorney for representatives in case the application is not presented by the applicant.
- 3. Payment of <u>Visa fees</u> must be done only through demand draft in favour of CONSULATE GENERAL OF SPAIN MUMBAI.
- 4. Passport with a minimum validity of 1 year and photocopy of all pages of the same.
- 5. **Refer to Annex I**, specific documents for each corresponding category.
- Police Clearance Certificate issued by the competent authorities of the country where the applicant has resided in the last 5 years prior to the submission of the visa application, legalised + authenticated/ apostilled. Only in case of adults over the penal age.
- 7. Public or private medical insurance policy issued by an insurance company authorized to operate in Spain.
 - Not required for visas for highly qualified professionals, researchers, interns and for intra-company transfer.
 - Not required for the spouse and children under 18.
- 8. Proof of sufficient economic means to attend to the living expenses, including if applicable, to the expenses related to his/her family, during the intended period of stay in Spain, and without practicing any professional activity.
 - Not required for visas for highly qualified professionals, researchers, interns and for intra-company transfer.
 - Not required for the spouse and children under 18.

ANNEX I

Specific Documents required for each category:

HIGHLY QUALIFIED PROFESSIONAL

a) Authorization of work and residence permit for highly qualified professionals.

INTRA-COMPANY TRANSFER

a) Authorization of work and residence permit for intra-company transfer.

TRAINING/RESEARCH

a) Authorization of work and residence permit for training/research.

ENTREPRENEURS

a) Favorable Report (Informe favorable) issued by the Economic and Commercial Office of Spain, Mumbai

FAMILY MEMBERS

- a. Authorization of residence permit
- b. Original document that justifies the family bond relationship with the regrouping person. A photocopy of the same must be submitted.
 - In case of India, this certificate (birth/ marriage) must bear the stamp of Apostille of Hague issued by Ministry of External Affairs, India.
 - In case of certificates issued by other countries, it should be legalized or apostilled.
 - Note: Marriage Certificate must be updated. Marriage Certificates have validity of three months, unless the certificate states otherwise.
- c. Photocopy of the residence card (TIE) and photocopy (biodata page/s) of the principal applicant in case s/he is already in Spain.

INTERNSHIPS

- a) Authorization of the residence permit for internship issued by the Government Delegation or Sub-delegation.
- b) Copy of the Hosting Agreement or Internship Contract
- * Family reunification for interns is not permitted, so it will not be possible to process residence visas for relatives of holders of a residence permit for this group.

CAPITAL INVESTMENT

- a) Unlisted shares or company shares of a private limited: Declaration of the investment made in the Registry of Foreign Investment of the Ministry of Economy and Competitiveness.
- b) Investment in listed shares: Certificate of the financial intermediary, duly registered in the National Securities Market Commission (Comisión Nacional del

Mercado de Valores) or in the Bank of Spain, in which it is mentioned that the applicant has made an investment to the effect of this norm.

- c) Public debt: Certificate of the financial organisation or the Bank of Spain, in which it is mentioned that the applicant is the sole holder of the investment for a period equal to or more than 5 years.
- d) Investment in Fixed Deposit: Certificate from the financial organisation in which it is mentioned that the applicant is the sole holder of the fixed deposit.

REAL-ESTATE INVESTORS

- a) Certification with information from the Real Estate Registry that corresponds to Real Estate property or properties.
- b) Deed of Sale accrediting the investment in a Real Estate property of 500,000 Euros, free and clear of all liens and encumbrances.

INVESTOR CORPORATE PROJECT

a) Favorable Report (Informe favorable) issued by the Economic and Commercial Office of Spain, Mumbai

OTHER REQUIREMENTS AND OBSERVATIONS

TRANSLATION: <u>Sworn translation</u> to Spanish from source language if the original documents are in a regional/foreign language (except passports and economic proof documents).

PHOTOCOPIES: Kindly note that for each original document presented a photocopy of the same must be submitted. The photocopies must be made after legalising the translations and/or the documents.

INTERVIEWS: At any time during the visa application procedure, this Consulate General may require the personal appearance of the applicant, and if considered necessary, conduct a personal interview.
