

FAMILY REGROUPING VISA WITH EU NATIONAL

BENEFECIARIES

- Spouse or registered common law partner of a Spanish national or EU national or nationals of other nations that are part of the European Economic Area Agreement and of Switzerland who are residents in Spain
- Direct descendants of Spanish nationals or EU nationals or nationals of other nations that are part of the European Economic Area Agreement and of Switzerland who are residents in Spain and those of their spouses or registered common law partner, not separated by law, below 21 years of age or above 21 years of age who are dependent on them
- Direct ascendants of Spanish nationals or EU nationals or nationals of other nations that are part of the European Economic Area Agreement and of Switzerland who are residents in Spain and those of their spouses or registered common law partner, not separated by law, who are dependent on them

DOCUMENTS REQUIRED

- 1. 2 <u>Schengen visa application</u> forms, duly filled out, signed by the person in whose name the visa will be issued and 2 recent passport size photographs in colour and with white background attached to the form.
- 2. Passport with a minimum validity of 1 year and photocopy of all pages of the same.
- 3. Original and photocopy of documents that justify the family bond relation through the corresponding registration in a Civil Registry of the member State or through a certificate of the authorities of Spain in which it is indicated clearly that the family bond or relationship are recognised:
 - a. Literal transcript of the Marriage certificate from **the Spanish Civil Registry** (not older than 3 months from the date of issue).
 - b. Birth and/or Marriage certificates from other EU / EEA / Switzerland.
- 4. Passport or certified document of the nationality of the regrouping person (original and/or attested photocopy). A photocopy of the same must be submitted.
- 5. In case of spouse or registered partner Declaration letter explaining the motive of travel of the spouse or registered partner. The signed letter should declare whether

the person being regrouped will travel with the EU citizen or regroup with them in Spain in case travelling alone.

- In case of direct ascendants or descendants Declaration done by the regrouping person before the Spanish Notary Public stating explicitly his/her consent to accomplish family reunification for the residence of the applicant. A photocopy of the same must be submitted.
- 7. In case of **direct ascendants, or descendants more than 21 years of age**, the economic dependence on the regrouping person must be justified through documents (documents that justify that at least during the last year, they have received funds from the regrouping family member up to an amount where the economic dependence on the regrouping person can be concluded). A photocopy of the same must be submitted.
- 8. In case of **minors**, no objection affidavit of the parent who will not be accompanying them duly apostilled expressing his/her wish to accomplish family reunification for the residence of the applicant in Spain, translated to Spanish if not in English. A photocopy of the same must be submitted.
- No visa fees (GRATIS visa) and submission of the application at the Consulate General of Spain in Mumbai <u>with a prior appointment</u> during the working hours from Mon-Fri 9:00 am - 1:00 pm.

OTHER REQUIREMENTS AND OBSERVATIONS

TRANSLATION: <u>Sworn translation</u> to Spanish from source language if the original documents are in a regional/foreign language (except passports and economic proof documents).

PHOTOCOPIES: Kindly note that for each original document presented a photocopy of the same must be submitted. The photocopies must be made after legalising the translations and/or the documents.

INTERVIEWS: At any time during the visa application procedure, this Consulate General may require the personal appearance of the applicant, and if considered necessary, conduct a personal interview.
